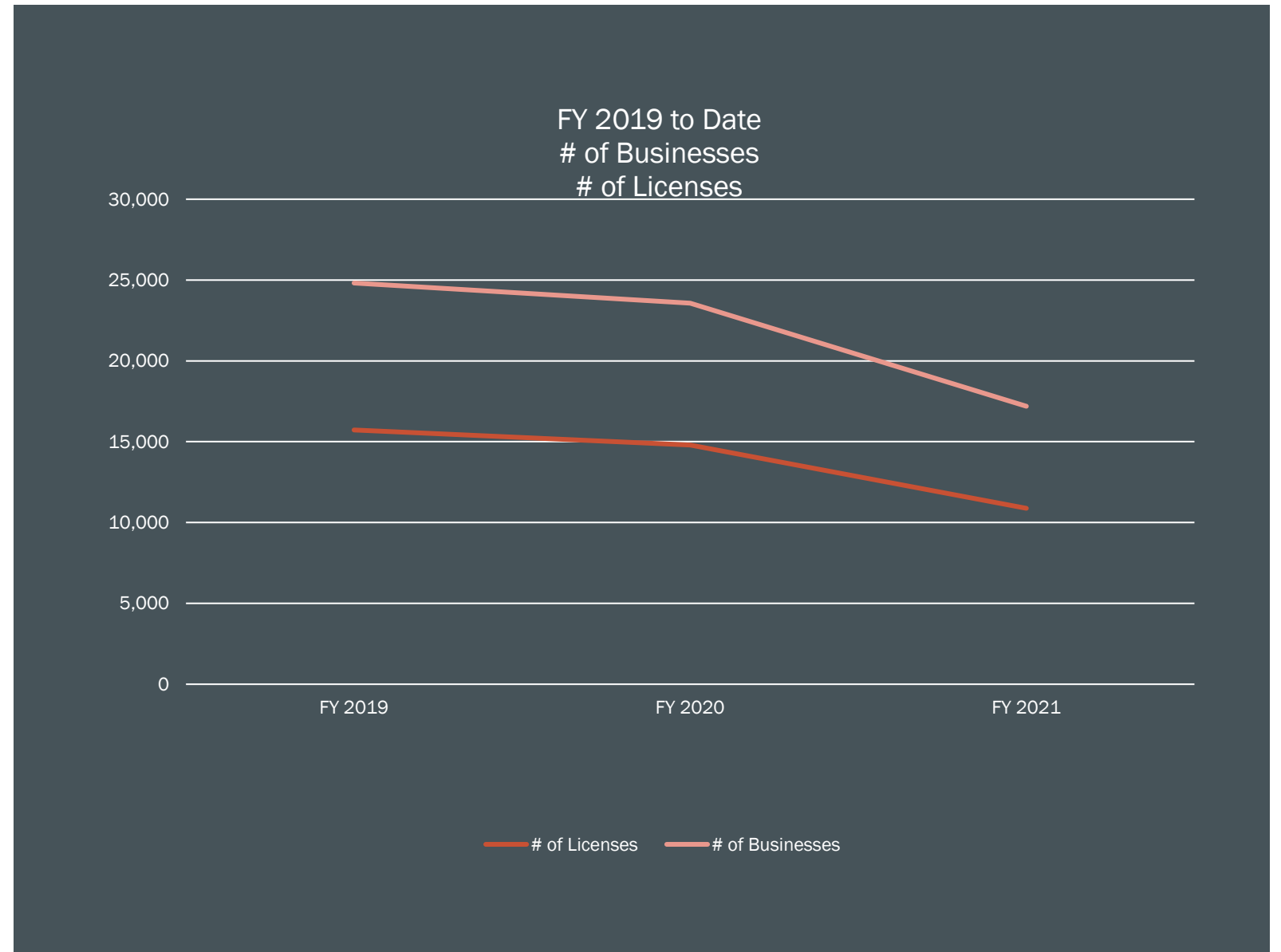

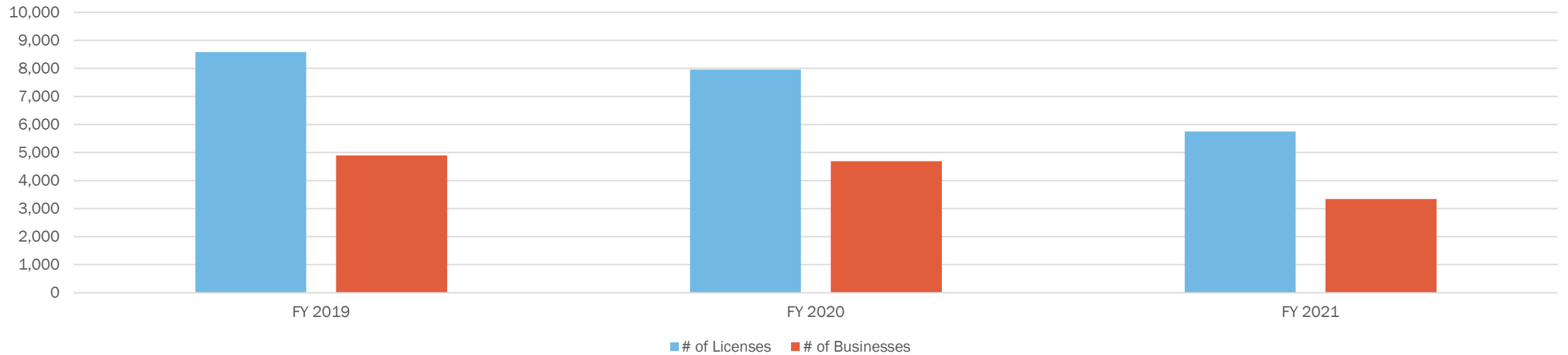

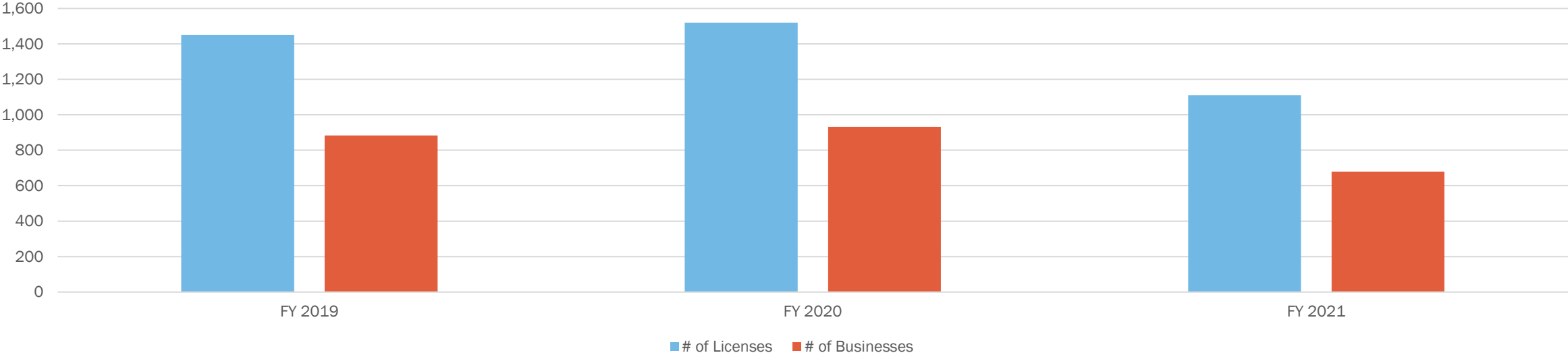

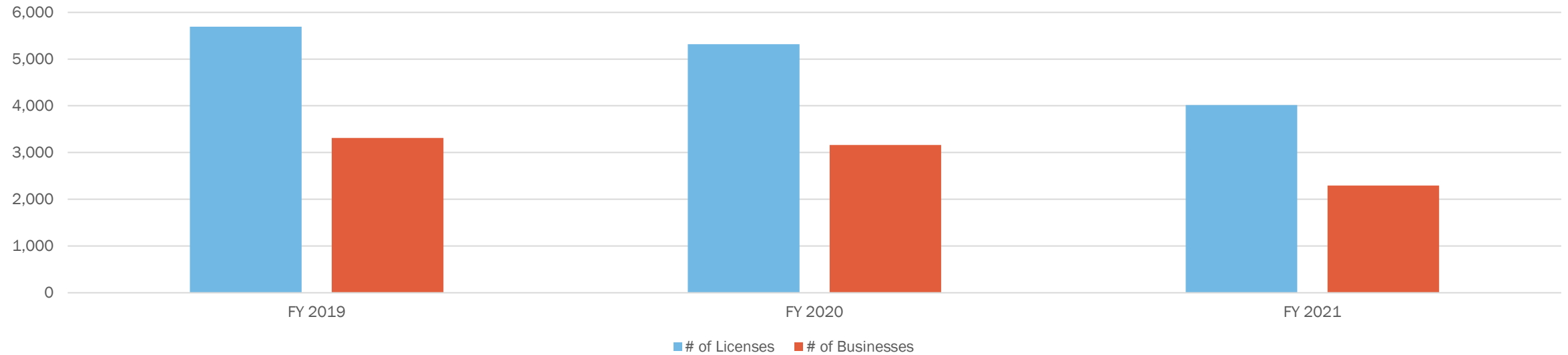

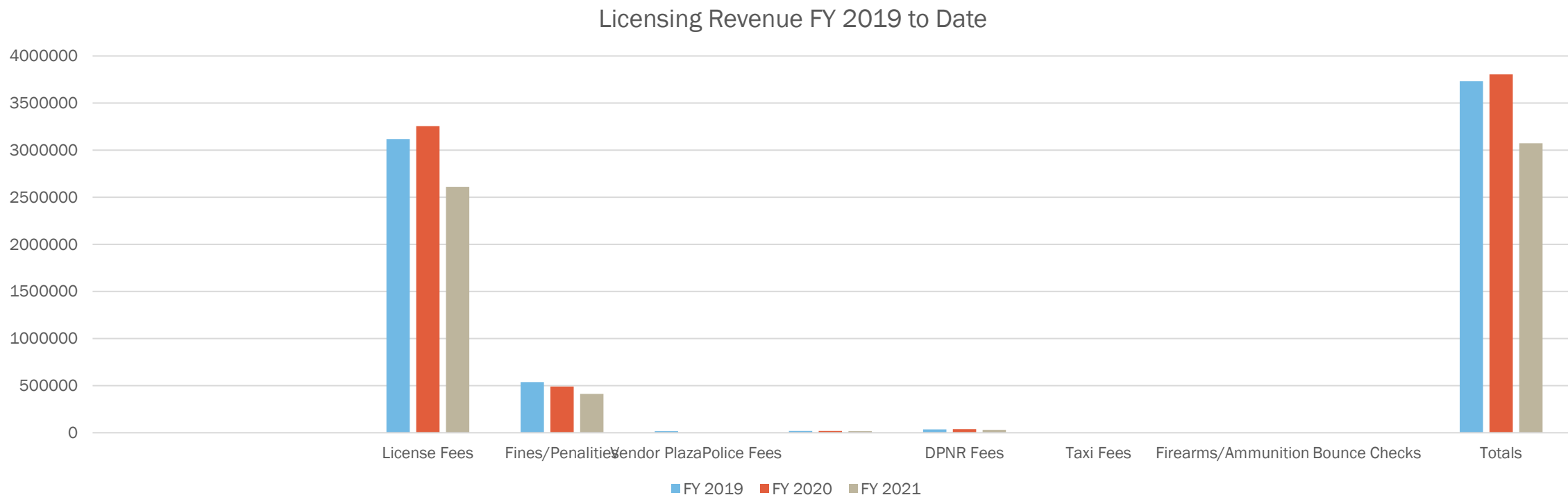

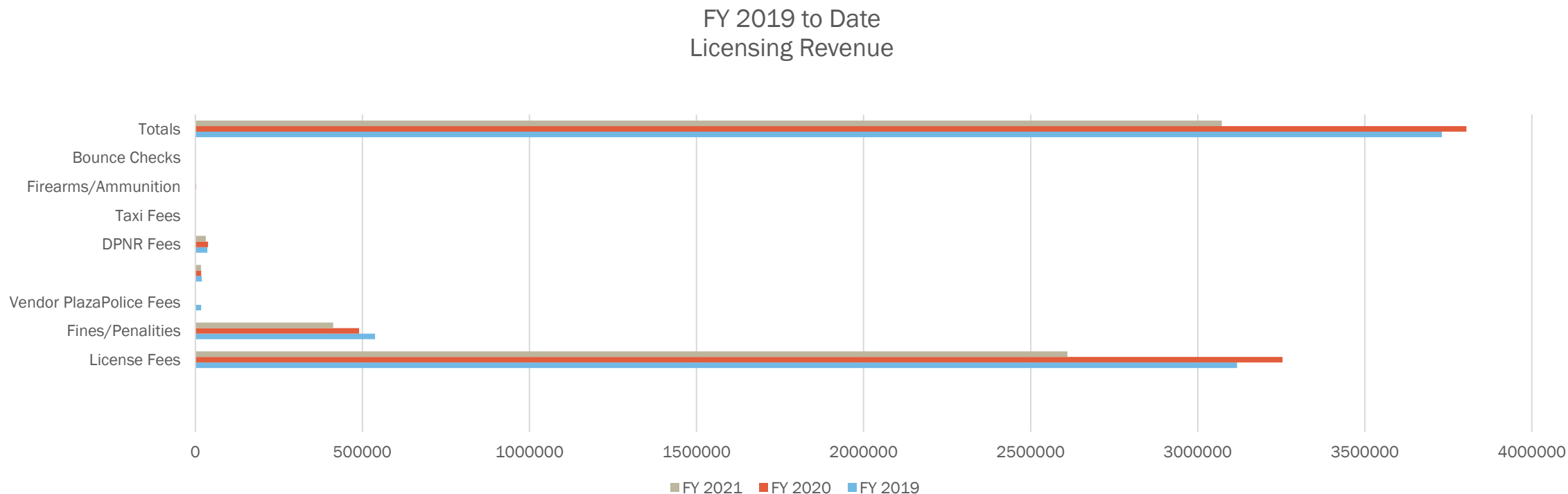

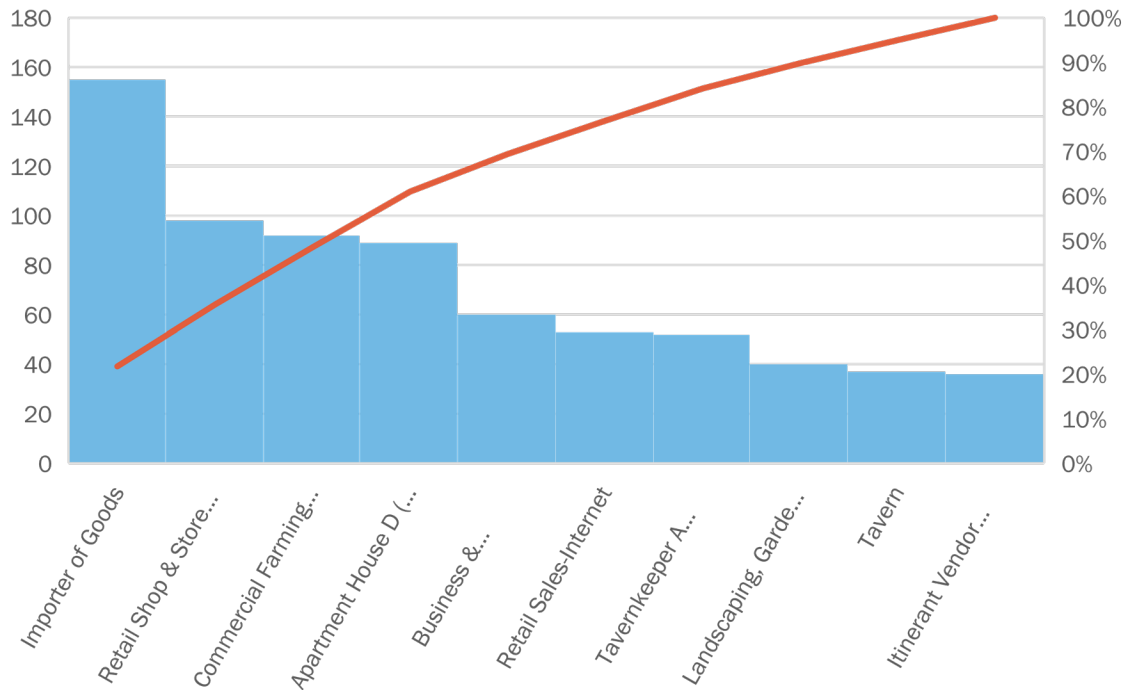

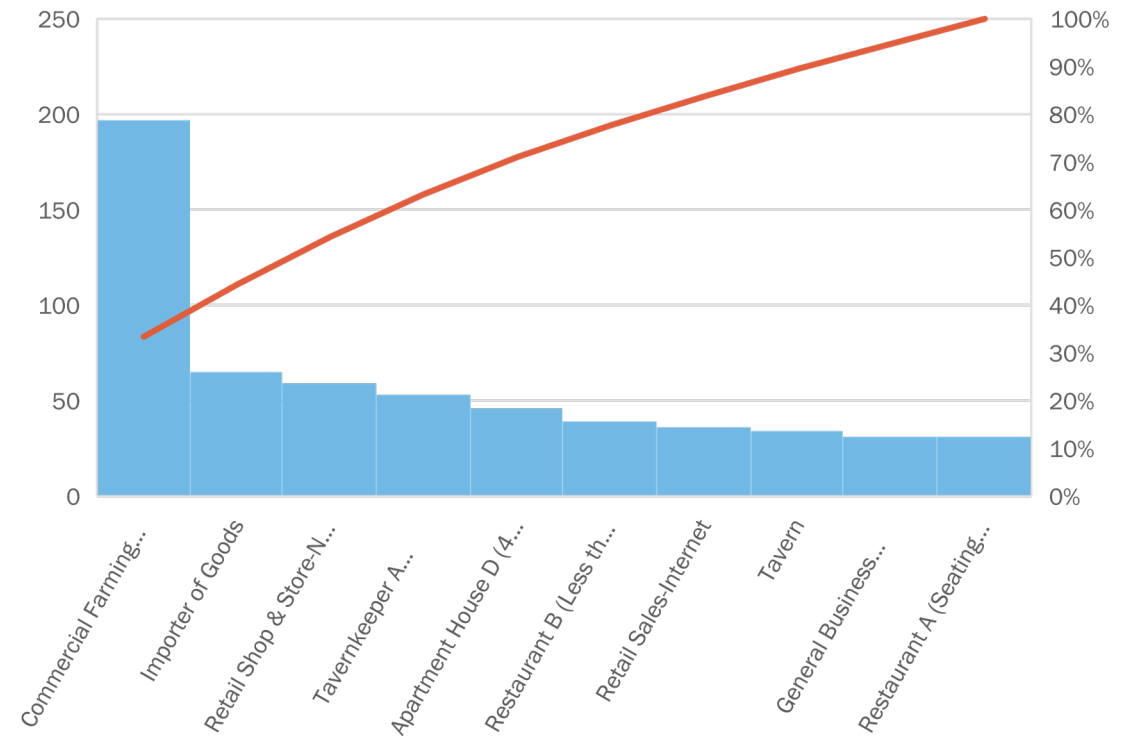

FY 20 New Business Licenses

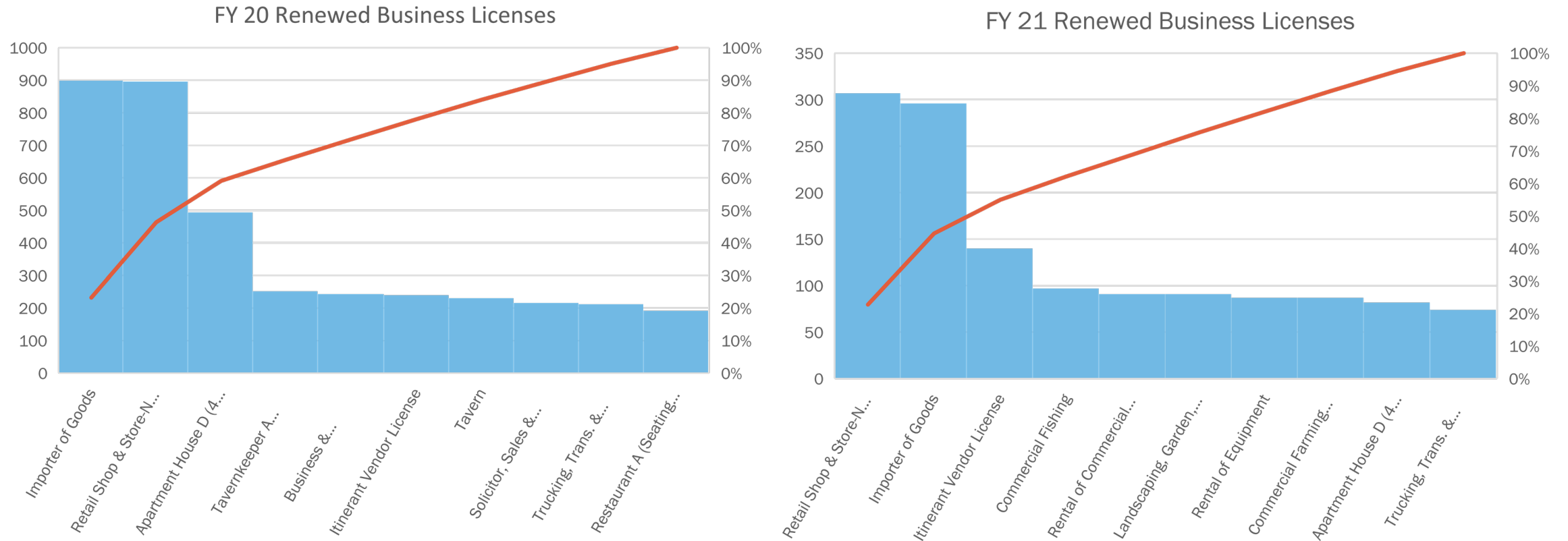


FY 21 New Business Licenses

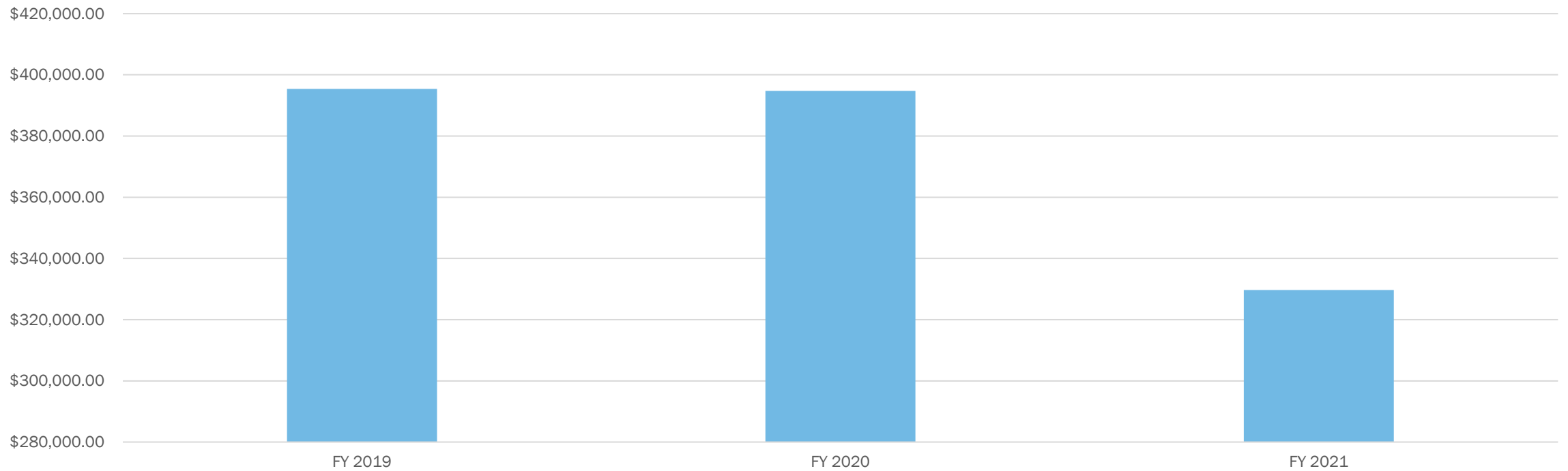

LICENSE FEE INCREASE

- The recent increase of COVID-19 positive individuals throughout the Territory in the past thirty (30) days is a clear sign that the pandemic has not yet settled and any projected increase in licensing fees shall not be implemented at this time. Instead, DLCA is encouraging unlicensed businesses to apply to renew its license and simultaneously submit a request to waive the penalties incurred due to economic difficulty created by COVID-19. DLCA shall revisit a license fee increase in the middle of fiscal year 2022.
